



Comprehensive Limited Warranty Effective: April 1, 2025

We, Adrian Steel Company warrant to you, the original purchaser, for every product **we both manufactured and installed** on your vehicle that our product and installation will be free from defects in materials and workmanship, for as long as you own the vehicle.

For every product **we manufactured, which is installed by an authorized distributor**, we warrant that our product only (not the installation) will be free from defects in materials and workmanship, for as long as you own the vehicle.

For every product we manufactured, that we or an authorized distributor sold but did not install, we warrant that our product only (not the installation) will be free from defects in materials and workmanship, for one (1) year after the date of purchase.

For every product that we install on your vehicle but did not manufacture, we honor the manufacturer's warranty, and we warrant our installation will be free of defects in workmanship for the same period.

For every product that **we did not manufacture, but we sold to an authorized distributor who installed it**, we honor the manufacturer's warranty on the product only (not the installation).

LIMITATIONS AND EXCLUSIONS:

- This warranty does not cover pickup covers and toppers, or Extendobed® products, which are covered under separate warranties.
- We only warrant products we manufacture or sell, if you purchase them from us or an authorized distributor. We only warrant installations that we perform. - Warranty coverage is limited to normal use and service, ordinary wear and tear excepted. Products which have been subjected to abuse, misuse, misapplication, accident, addition, alteration, modification, or tampering will not be covered by this warranty.
- Warranty coverage is limited to the original owner and the original installation. Warranty coverage ends if the original vehicle is sold, or the product is removed from the original vehicle.
- The following void the warranty: loading the product beyond the recommended load capacity, or the vehicle beyond the federal GVWR, or otherwise violating the rules of operation.
- Damage from severe weather (such as storms, tornados, hurricanes, hail, earthquakes, or extreme heat, cold, or humidity) is not covered.
- Surface rust or corrosion that has not perforated the product is not covered.

You may submit warranty claims to your sales representative, your customer service representative, or our Customer Care Department. You must deliver the vehicle to us (either to the original installer or another authorized location we designate), for inspection and any warranty service. We reserve the right in our sole discretion to inspect our product and the vehicle on which it was installed, and to adjudicate warranty claims. We reserve the right to deny any claims if we are not able to properly inspect the affected product and vehicle.

This warranty may not be transferred or assigned. We do not authorize anyone (including but not limited to any of our distributors, dealers, or employees) to alter this warranty.
